**Part-A) Promotion :**

- i) The above mentioned officials, being promoted as per this order, are liable to be reverted without prior notice at any time.
- ii) The inter-se seniority of the abovementioned persons in the promotional cadre of Inspector will be fixed enbloc immediately below **Shri Manas Kr. Saha (DOB : 07.10.1966)**, the last person promoted as Inspector against **Recruitment Year 2012-13** vide **Order No. 139** dated **06.11.2012** of **F. No. 4E/4/2012-13**.
- iii) The above promotees are hereby asked to exercise their option within one month of the date of promotion in the matter of fixation of pay on such promotion in terms of Clarification 2 of O.M. F. No. 1/1/2008-1C G.I.M.F, Deptt. of Expenditure ( Implementation Cell ) dated 13<sup>th</sup> September, 2008.
- iv) It may be noted that in the event of refusing the above promotion the officials getting promotion as per this order shall be debarred from promotion to the post of Inspector for a period of one year from the date of refusal of the said promotion or till a next vacancy arises, whichever is later, as per the D.O.P & T's O.M. No. 22011/5/91-Estt.(D) dated 27.03.97.
- v) The persons appearing at **Sl.No. 3, 4, 7, 12, 13, 16, 21, 24, 29 and 31** in the above table are selected for promotion against available **SC vacancies** & **Sl no 1, 5, 8, 18, 26, 80 & 82** are selected for promotion against available **ST vacancies** . All other persons are selected against **unreserved vacancies**.
- vi) Promotions of the above said persons are given on the basis of the existing Recruitment Rules, as directed vide Board's letter dated 27.05.2014, and as per the existing gradation lists of the feeder grades. This order will remain subject to revision contingent upon the revision, if any, of the said gradation lists of feeder cadres in view of the decision of the Hon'ble Supreme Court read with DOPT' s O. M. dt 04.03.2014 & CDBT's letter dt 06.06.2014 communicating further clarification of the DOPT in this regard.
- vii) No person holding the post of Stenographer Gr-II(erstwhile Stenographer Gr-III) bearing Grade Pay of Rs. 2400/- as on 01.01.2013(the crucial date for promotion of the R.Y. 2013-14) figure in the above list, in accordance with an interim decision of the Hon'ble CAT,Calcutta Bench, Kolkata dt 04.06.2014, in O.A. No. 259/2013, read with M.A. No. 164/2014 directing to exclude Stenographer Gr-II (erstwhile Stenographer Gr-III) bearing Grade Pay Rs. 2400/- from consideration zone for the purpose of promotion to the grade of Inspector.
- viii) The promotees concerned are directed to join on promotion as Inspector at the earliest. They are also directed to intimate their unwillingness, if any, to accept the promotion to the post of Inspector to this office by **30.06.2014** positively..

**Part-B: Posting**

- i) On promotion as Inspector of Income Tax, the services of the officials mentioned in Part – A are retained at their present places of postings until further orders.
- ii) The above posting on promotion is purely temporary and the promotees concerned are liable to be transferred to any office within the Principal CCIT West Bengal and Sikkim region in Annual General Transfer.
- iii) Head of offices are requested to ensure that the copy of the joining report is sent to the office of the Addl.C.I.T.,Hqrs.,(Personnel), Kolkata as soon as the said persons join on promotion.
