Part-A) Promotion :

- iii) The above **promotees** are hereby asked to exercise their option within one month of the date of promotion in the matter of fixation of pay on such promotion in terms of Clarification 2 of O.M. F. No. 1/1/2008-1C G.I.M.F, Deptt. of Expenditure (Implementation Cell) dated 13th September, 2008.
- iv) It may be noted that in the event of refusing the above promotion the officials getting promotion as per this order shall be debarred from promotion to the post of Inspector for a period of one year from the date of refusal of the said promotion or till a next vacancy arises, whichever is later, as per the D.O.P & T's O.M. 
