Kindly find enclosed an instruction issued by the Asstt. Director of Income-tax (Exam), New Delhi vide No-OA-542/1995/CAT Cuttak/2002/DIT dated 22.05.2009 wherein it has been decided that where the Exam is held in a particular year and the result thereof is declared in any subsequent calendar, the effective date of passing the Exam shall be deemed to be the 1st of January of the calendar year in which the result has been declared. The instruction has been made operational prospectively i.e with effect from Departmental Examination-2008 onwards till the Departmental Examination 2010, as per instruction dated 22.12.2011 issued by the Directorate of Income-tax(IT).

Accordingly, the undersigned has been directed to bring it to the notice of all concerned that the date for grant of advance increments for passing the Departmental Examination- 2008 onwards till the Departmental Examination- 2010, will be the 1st day of January of the calendar year in which the result has been declared.
