Sub: Relaxing the restriction imposed on promotion to the posts in different Group B & C grades
in West Bengal , earmarked for phasing out - Request regarding -

Kindly refer to the above.

The CBDT has issued an instruction on 15th March, 2016 to all Principal CCsIT (CCA) to conduct DPCs for the posts in various Group B & C grades against the vacancy year 2016-17. Accordingly, DPCs are being held for vacancy year 2016-17 in various regions. But WB & Sikkim region is facing a unique problem to hold the DPCs for filling up the vacant posts in spite of having eligible candidates in abundance.

It is known to you that the Principal CCIT, WB & Sikkim had earlier been directed not to fill up the Group B & C posts out of 1633 posts earmarked for phasing out till final decision to be taken by the Board in this regard. As a result, DPCs can't be held for certain grades, which could have otherwise addressed the acute stagnation faced by that region in all grades.

You are aware that the Central JCA has already filed a detailed reply in response to the draft report submitted by the committee, constituted under the chairmanship of the then ADG, HRD-II to review the phasing out proposal. In our reply it has been categorically established with sufficient supporting that other regions are not even in a position to fill up the existing vacancies for want of eligible candidates, leave alone the posts of various grades, to be received from WB & Sikkim region under phasing out proposal, Hence withdrawal of phasing out plan won't affect normal career progression of our members in other regions. We are very much hopeful that the Board will accept our demand.

In view of the above, it is requested to kindly withdraw the order dated 4th April, 2014 regarding phasing out or relax the restriction imposed on promotion to the posts in different Group B & C grades in West Bengal & Sikkim region, earmarked for phasing out for the vacancy year 2016-17 and instruct the Principal CCIT, WB & Sikkim to immediately hold the DPCs to fill up all vacant posts including those earmarked for phasing out by eligible candidates in order to address the stagnation.
