CIRCULAR

**Sub: Circulation of Final Seniority Lists of the cadres of i) Head Clerk / Assistant, ii) Supervisor, Grade - II / Office Superintendent, & iii) Tax Assistant (Pre - restructuring), in the region of West Bengal and Sikkim -- Matter regarding.**

In view of the Hon'ble Apex Court's judgment in the case of N. R. Parmar vs. Union of India and Ors., (Civil Appeal Nos. 7514 - 7515 of 2005) and in pursuance of the DOP & T's O. M. No. / 20011 / 1 / 2012 - Estt. (D) dated 04.03.2014, communicated by the CBDT vide instructions in F. No. HRD / CM / 220 / 14 / 2013 - 14 / 153 / 2014 - Ad. - VII dated 13.03.2014, and CBDT's guidelines dated 29.09.2014, 07.11.2014, & 16.01.2015, the gradation lists of UDC (Pre - restructuring) have already been recast and notified. On the basis of such revision, seniority lists of the following cadres pertaining to vacancy years as mentioned in the table below have been recast in the region of West Bengal & Sikkim, by holding the review DPCs. Such revised seniority lists are hereby notified as per approval of the Principal Chief Commissioner of Income Tax, West Bengal & Sikkim.

03.	Tax Assistant (Pre – restructuring)	1991 – 92 up to 2000 – 2001	No recasting is necessary in the seniority lists for the vacancy years: 1986 – 87 up to 1990 – 91, even after taking into account the revision in the seniority lists of the feeder grades

It may be noted that, all of the above cadres were 100 % promotional cadres, and rota – quota method is not applicable in these cadres.

No representation has been received in this office of the undersigned after publication of the tentative seniority lists in the matter pertaining to the Recruitment Years as mentioned above.
