Kolkata, dated the 15th November, 2014.

1. In pursuance of the Director General of Income-tax (Human Resources Development), Central Board of Direct Taxes, New Delhi Communication from F. No. HRD/CM/102/28/2013-14/27 dated 4th March, 2014 and subsequent Corrigendum from F. No. HRD/CM/102/28/2013-14/4488 dated 17th October, 2014 and further communication from F. No. HRD/CM/102/28/2013-14/6789 dated 15th November, 2014 and in suppression of all earlier orders on the subject, except as respects things done or omitted to be done before such suppression, the principal Chief Commissioner of Income-tax, West Bengal and Sikkim hereby directs:-

(a) abolition of existing charges of Designated posts under the administrative control of the Director of Income-tax, (Intelligence and Criminal Investigation), Kolkata;

(b) creation of Designated posts headed by Additional Director of Income-tax / Joint Director of Income-tax specified in column (4) of the Schedule annexed hereto having their headquarter specified in the corresponding entry in column (3) of the said Schedule which shall function under the Income-tax Authorities specified in the corresponding entry in column (2) of the said Schedule;

(c) creation of Designated posts headed by Deputy Directors of Income-tax / Assistant Directors of Income-tax specified in column (4) of the Schedule annexed hereto having their headquarter specified in the corresponding entry in column (3) of the said Schedule which shall function under the Income-tax Authorities specified in the corresponding entry in column (2) of the said Schedule;
