NOTIFICATION NO. 15/2014

(Income-tax)

Kolkata, dated the 15th November, 2014.

1. In pursuance of Order dated 14th November, 2014 of the Central Board of Direct Taxes in F.No.187/45/2014 – (ITA. I) and notification No. S.O. 2753 dated 22nd October, 2014 and in pursuance of the Director General of Income-tax (Human Resources Development), Central Board of Direct Taxes, New Delhi communication from F. No. HRD/CM/102/28/2013-14/27 dated 4th March, 2014 and subsequent Corrigendum from F. No. HRD/CM/102/28/2013-14/4488 dated 17th October, 2014 and in suppression of all earlier orders on the subject, except as respects things done or omitted to be done before such suppression, the Principal Chief Commissioner of Income-tax, West Bengal and Sikkim hereby directs:-

(a) abolition of existing charges of Designated posts under the administrative control of the Commissioner of Income-tax, (Audit)-I, Kolkata, Commissioner of Income-tax, (Audit)-II, Kolkata;

(b) creation of Designated posts headed by Additional Commissioner of Income-tax / Joint Commissioner of Income-tax specified in column (4) of the Schedule annexed hereto having their headquarter specified in the corresponding entry in column (3) of the said Schedule which shall function under the Income-tax Authorities specified in the corresponding entry in column (2) of the said Schedule;

(c) creation of Designated posts headed by Deputy Commissioner of Income-tax / Assistant Commissioner of Income-tax specified in column (4) of the Schedule annexed hereto having their headquarter specified in the corresponding entry in column (3) of the said Schedule which shall function under the Income-tax Authorities specified in the corresponding entry in column (2) of the said Schedule;

(d) creation of Designated posts headed by Income Tax Officers specified in column (4) of the Schedule annexed hereto having their headquarters specified in the corresponding entry in column (3) of the said Schedule which shall function under the Income-tax Authorities specified in the corresponding entry in column (2) of the said Schedule.

2. This order shall come into force with effect from 15th of November, 2014.
